Karl A. Doss Joins the Virginia Law Foundation as Vice President of Continuing Legal Education

With more than 30 years of experience in attorney training, legal policy analysis, governance, and litigation, Doss now plays an integral role in the success of Virginia CLE, the Virginia Law Foundation's extensive education division. In this role, he oversees several key departments of the legal education mission, including seminars, distance learning, and publications. Previously, he served as deputy legal



officer for governance at Virginia Union University, director of workforce diversity at Freddie Mac, deputy director for the Legal Services Corporation of Virginia, and director of access to legal services at the Virginia State Bar. Doss also served as director of training and professional development for the National Legal Aid & Defender Association, director of judicial programs at the Supreme Court of Virginia, and director of training and attorney certification at the Virginia Indigent Defense Commission.

Earlier in his career, Doss served as a law guardian in Brooklyn, New York, and as a public defender, prosecutor, and judicial officer in Minneapolis, Minnesota. A graduate of the University of Minnesota School of Law and Tulane University, he currently serves on the board of the Virginia Poverty Law Center, is a member of the Virginia State Bar's Standing Committee on Access to Legal Services, and a 2023 Fellow of the Virginia Law Foundation.

"We are excited to welcome Karl to our team. He brings unique skills, fresh perspectives, and a shared passion for our mission," said **Brigadier General (ret.) Alison Martin.** "His addition marks another important step in building a stronger, more dynamic organization—one that is better equipped to meet the challenges ahead.
