The Virginia Law Foundation Inducts Class of 2025 Fellows

Nominated confidentially by their peers and selected by the Fellows Committee, each VLF Fellow must be a member of the Virginia State Bar for at least ten years, reside in Virginia, exhibit highest integrity and character, uphold the highest professional standards, and be outstanding community members, distinguished in the practice of law. Fellows play a vital role in advancing the VLF's mission, which is to promote, through philanthropy, the Rule of Law, access to justice, and law-related education.
